Message from the President

This is my final President's message. The past 15 months have been without precedent. Covid-19 has affected virtually every aspect of life on our planet. Canada has not been spared. Lockdowns, stayat-home orders, curfews, public health directives including the mandated wearing of masks and prohibition of mingling with family and friends were measures not ever

instituted in North America. Drastically reduced social gatherings including weddings, funerals and other milestones of life. Tens of thousands of people dying lonely, from Covid or other causes, without their loved ones to comfort them. Students not allowed to attend schools with great concern for their mental health, and indeed of almost the entire society. Great political upheaval, racial tensions, discussions about climate change, change in governments and government structures in the United States, Europe, Britain and elsewhere. At times, it seemed like a perfect storm of bad things

Our Society has also been forced to weather the winds of this pandemic. Last year, the Board, in what looks now like a very halting way, made the decision to cancel our Annual Meeting that was

planned for Quebec City. This was the first time in 73 years that such a decision had been made. The Board still had to comply with rules and regulations of government oversight for not-for-profit organizations, but our By-laws did not provide mechanisms to discharge those duties without the member-oversight at our annual business meeting. Board transition was postponed by a year to keep the 2019-2020 Board in place and assure continuity of the administration of the Society. The Board has been able to work around administrative constraints and, within the parameters of the existing By-laws has amended our By-laws to allow for more modern oversight of our members in future business meetings. Our By-law amendments now allow for electronic business

Dr. Howard Clarke to Receive CSPS 2021 Lifetime Achievement Award

DR. HOWARD MARTYN CLARKE completed his formative medical, residency, and research training at the

University of Toronto, graduating with his medical degree in 1977. He was one of the very early surgeon scientist trainees, obtaining his PhD in 1985 after completing a doctoral thesis entitled "The Microcirculation of Skin Flaps" under the supervision of Dr. Ralph Manktelow. Following his residency in Toronto, he successfully passed his Canadian fellowship exams in 1987. Dr. Clarke subsequently did clinical fellowships in Boston and Japan before starting a staff position at the Hospital for Sick Children in 1987. He was promoted to full Professor in 2013; and has been a remarkable contributor to the Canadian landscape of Plastic Surgery. The opportunities provided by working at a single institution all of his career have enabled him to develop a robust and enviable academic career. Over a 34-year period, Dr. Clarke has honed his craft in the management of complex congenital hand anomalies, burns and cleft lip and palate.

His true mark on the international landscape of surgery has been in obstetrical brachial

plexus palsy (OBPP), as one of the pioneers of current surgical practice for infants who have sustained this injury. His interest and dedication have led to the creation of an institutional OBPP program, a robust database, the radical approach to resection and cable-grafting lesions of the infant brachial plexus, the development of the Active Movement Score with physiotherapist Chris Curtis, a bi-annual Toronto OBPP workshop and the opportunity to generously share his knowledge with generations of residents and fellows across the country and around the

In memoriam - Dr. Alan Campbell-Moscrop



In February 2021, we lost our colleague Dr. Alan Campbell-Moscrop. He was a well-respected surgeon who attended medical school in England. Upon his immigration to Canada, he practiced briefly in Newfoundland before

moving to Montreal to train at McGill University as a plastic surgeon. He was a CSPS member since 1972 and practiced in Hamilton for over 40 years. Until his retirement in 2014, he was associated with St. Joseph's Hospital and McMaster University as Clinical Assistant Professor.

"CM" as he was affectionately known, was very kind to all - colleagues, patients and hospital staff. He was always very supportive of the training program, residents, and in particular, medical students. He won the Mission Legacy Award from St. Joseph's Hospital in 2007.

As he neared retirement, he opened a bed & breakfast called *Serenity Ranch* in Ancaster in 2008. Serenity Ranch was ranked #1 in Canada and #14 in the world in 2017. In 2020, during covid, Serenity Ranch was ranked #3 in Canada and #17 in the world.

"CM" will be greatly missed. The Society extends our heartfelt sympathies to his family, friends and colleagues for their loss.

globe. There are no cities in Canada where surgeons performing care for OBPP patients have not been trained by Dr. Clarke. His scope of influence extends globally having been involved in the training of more than 75 fellows. He has also mentored many health care providers in Rehabilitation Medicine.

While Dr. Clarke started his career with a heavy focus on basic science research continuing his interest in the microcirculation, he has transitioned to the role of Surgeon-Teacher. He consistently obtains high teaching effectiveness scores from residents and fellows and has been recognized at the highest level receiving the PAIRO Teaching award and the citywide divisional Arnis Frieberg Teaching award. He takes great pride in watching his mentees adapt his techniques to continue to improve treatment and care for children.

Dr. Clarke harbours a strong interest in the development and evolution of the plastics specialty and the societies and institutions that guide its practitioners. He has been actively involved in CSPS leadership, culminating in his Presidency in 2015. He also extended his political influence to the development of ICOPLAST (the International Confederation of Plastic Surgery Societies) and was their President in 2018. He is a former President of the ASPN and has been an active member in the Plastic Surgery Research Council, the Sunderland Society and the Narakas Society; and has also served as a Royal College examiner for many years.

Dr. Howard M. Clarke will be awarded the CSPS Lifetime Achievement Award during the President's Banquet at the next in-person CSPS Annual Meeting, on the evening of Friday, June 17, 2022 at the Fairmont Château Frontenac Hotel in Quebec City. On the same occasion, Dr. Richard Warren will receive the 2020 Lifetime Achievement Award, which has been delayed due to restrictions imposed by the Covid-19 pandemic.

Description of the Award

Nominations for the 2022 Award will be accepted until January 19, 2022.

In addition, nominees previously proposed will be carried over for consideration.

Purpose

This award honors an established plastic surgeon who is a member of the Canadian Society of Plastic Surgeons and has made an outstanding contribution to the profession and to the CSPS. The award will be made on the basis of teaching, research, innovation and service to the community or other endeavors. Nominees for this annual award will be reviewed by the CSPS Nominating Committee.

Eligibility

Members in good standing of the CSPS for at least 20 years are eligible.

The Award

The Award consists of the waiver of registration fees for the Annual Meeting in the year in which the award is bestowed and a plaque given at the annual President's Banquet.

Nomination Procedure

The complete nomination consists of a letter from a member of the CSPS formally proposing the nominee and outlining the nominee's specific contributions to plastic surgery and to the Society accompanied by the nominee's curriculum vitae.
