

<u>Plastic Surgery – Academic Surgeon</u>

The Department of Surgery (www.surgery.queensu.ca) at Queen's University is seeking a General Plastic Surgeon for a geographically full-time position in the Division of Plastic Surgery. A Locum Tenens appointment is also available to support this position. The candidate will have completed a minimum of a one-year Plastic Surgery Fellowship training at the commencement of their appointment. Additional fellowship training or an advanced degree would be advantageous in the competition. The successful candidate will be expected to have clinical expertise in and be comfortable managing all commonly accepted aspects of Plastic Surgery including Trauma and Oncology with the opportunity to develop a niche practice in their area of clinical interest. The preferred candidate must have an excellent record of success working in a multi-disciplinary clinical environment. They must demonstrate strong potential for outstanding educational contributions and significant academic and scholarly research in line with the mission of the Division of Plastic Surgery. Evidence of current involvement and commitment to research through the submission of a research dossier outlining an academic plan and career goals is requested if available. Applicants will also be involved in undergraduate and post-graduate medical education. Submission of an educational dossier is encouraged if available.

Qualified applicants will hold an MD degree (or equivalent), have completed postgraduate / fellowship qualifications prior to appointment, and have or be eligible for licensure with the College of Physicians and Surgeons of Ontario and certification from the Royal College of Physicians and Surgeons of Canada.

The successful candidate will join a collegial group as the sixth full-time member of the Division of Plastic Surgery and participate in the on-call schedule within the Division. Resources and call are equally divided among Division members; available resources include clinics, minor procedures and OR time. The successful candidate will also be expected to contribute to the teaching, supervision, and mentorship of undergraduate, graduate, postgraduate students and fellows. Queen's University is recognized nationally for the quality of its undergraduate and graduate programs, which attracts outstanding students.

Queen's University is an integral part of the vibrant Kingston community in the heart of the Thousand Islands region of southeastern Ontario. The University invites applications from all qualified individuals. Queen's is strongly committed to employment equity, diversity, and inclusion in the workplace and encourages applications from Black, racialized/visible minority and Indigenous people, women, persons with disabilities, and 2SLGBTQA+ persons. All qualified candidates are encouraged to apply; however, in accordance with Canadian immigration requirements, Canadian citizens and permanent residents of Canada will be given priority. Applications from all qualified candidates will be considered in the applicant pool. In order to support your employment at Queen's, we require you to indicate whether or not you will need a work permit.

The review of applications is on-going and will continue until the position is filled. Applications are to include a letter summarizing expertise, qualifications, and accomplishments relevant to the position, a CV, and the names and full contact information of three referees. The cover letter should also indicate whether or not you will require a work permit and/or require support with an extension of your work permit in the future. Submission of an educational dossier is also encouraged if available.
